1) Call to Order

Meeting was called to order at 12:02 p.m.

2) Roll Call

In attendance were President Rafferty, Secretary Allen, Treasurer Reade, Past President Rose, Director Barget, and Director Geyer.

3) Changes to the Agenda

4) Approval of Meeting Minutes from March 1 Board Meeting.

6) Reports

a. CSDA Regional Report

Charlotte Holifield reported The California Air Resources Board (CARB) has released an updated draft of its proposed Advanced Clean Fleet (ACF) Regulation and special districts and others have until April 7, 2023 to respond to the formal 15-Day Comment Period. CARB's regulation seeks to mandate zero emission vehicles (ZEV) for all medium-duty and heavy-duty vehicles purchased starting January 1, 2027, with many agencies required to purchase 50 percent ZEV from 2024 – 2026. This will have a major impact on local agencies using Class 2b – 8 vehicles (those vehicles with gross vehicle weight rating of 8,500 lbs. or more). CSDA will submit a formal comment letter together with city and county partners and is encouraging all affected special districts to submit their own comment letter.

CSDA is seeking member feedback on Assembly Bill 1637 (Irwin), which would require the following: No later than January 1, 2025, a local agency, including a special district, that maintains an internet website for use by the public will be required to ensure that the internet website utilizes a ".gov" top-level domain or a ".ca.gov" second-level domain. A local agency that maintains public email addresses for its employees will also be required to ensure that each email address provided to its employees utilizes a ".gov" domain name or a ".ca.gov" domain name. If a local agency maintains a website for use by the public that is noncompliant by January 1, 2025, it will be required to redirect that website to a domain name that does comply.

AB 557 (Hart) would extend the provisions of AB 361. CSDA is seeking letters of support.

Legislative Days are scheduled for May 16-17 in Sacramento.

b. Treasurer's Report

Treasurer Reade emailed the Treasurer's Report to the board on April 5, 2023. The balance in checking is \$16,444.87. Two deposits in the amounts of \$1,150.00 were made: Dinner receipts for \$1,000.00 and a dues payment by Guadalupe Cemetery District for \$150.00. Two checks were written one to La Botte Bistro in the amount of \$1,443.00 and one to Cynthia Allen for website costs in the amount of \$380.57.

An offer has been made and the new employee is scheduled to start on April 17 so, hopefully, her workload will go back to normal.
